

ORDINANCE NO. 2013- 0148

AN ORDINANCE OF THE COUNCIL OF THE CITY OF CAMPBELL STATE OF OHIO, FOR THE IMPOSITION OF A 3 MILL PROPERTY TAX RENEWAL LEVY FOR A PERIOD OF FIVE (5) YEARS TO BE USED FOR THE SAFETY FORCES OF THE CITY OF CAMPBELL PROVIDED THAT SUCH LEVY IS APPROVED BY THE ELECTORS OF THE CITY OF CAMPBELL.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMPBELL, STATE OF OHIO:

SECTION 1. That subject to the approval of the electors of the City of Campbell, Ohio, and in accordance with Section 5705.03 of the Ohio Revised Code, the Council of the City of Campbell does hereby request a property tax renewal levy for the assessment of three additional mills for a period of five years.

SECTION 2. That the purpose of the proposed tax herein shall be allocated to provide funds for the Safety Forces of the City of Campbell. Safety Forces being the Police Department and the Fire Department of the City of Campbell, and that the proposed tax is a renewal.

SECTION 3. That the tax for the purpose specified in Section 1 and Section 2 hereof, shall commence in 2013 for the purpose of collection of said tax in 2014. First due in calendar year 2014, and shall be in effect for a period of five (5) years.

SECTION 4. That it is the desire of the Council that the ballot presented to the electors of the City of Campbell for the November 5, 2013 General Election shall be in substantially the following form:

SHALL THE 3 MILL LEVY ON PROPERTY, APPROVED BY THE VOTERS AT THE MAY 6, 2003 SPECIAL ELECTION FOR THE PURPOSE OF PROVIDING FUNDS FOR THE SAFETY FORCES; POLICE & FIRE DEPARTMENTS OF THE CITY OF CAMPBELL BE CONTINUED FOR A FIVE (5) YEAR PERIOD COMMENCING IN 2013, FIRST DUE IN CALENDAR YEAR 2014 BE PASSED?

FOR THE 3 MILL RENEWAL LEVY
AGAINST THE 3 MILL RENEWAL LEVY

SECTION 5. That the a certified copy of this ordinance shall be presented to the Mahoning County Board of Elections in order that the Board of Elections may make the necessary arrangements for the submission of such question to the electors of the City of Campbell at the November 5, 2013, General Election, as provided by law.

SECTION 6. That it is the desire of the Council that the ballot presented to the electors of the City of Campbell shall be substantially the following form:
