

AN ORDINANCE OF THE COUNCIL OF THE CITY OF CAMPBELL STATE OF OHIO, FOR THE IMPOSITION OF A THREE AND A HALF (3.50) MILL PROPERTY TAX RENEWAL LEVY FOR A PERIOD OF FIVE (5) YEARS TO BE USED FOR THE OPERATING EXPENSES OF THE GENERAL FUND OF THE CITY OF CAMPBELL PROVIDED THAT SUCH LEVY IS APPROVED BY THE ELECTORS OF THE CITY OF CAMPBELL AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAMPBELL, STATE OF OHIO:

SECTION 1. That subject to approval of the electors of the City of Campbell, Ohio, and in accordance with Section 5705.03 of the Ohio Revised Code, the Council of the City of Campbell does hereby request a property tax renewal levy for the assessment of three and a half (3.50) additional mills for a period of five (5) years.

SECTION 2. That the purpose of the proposed tax herein shall be for current operating expenses of the City of Campbell. That the proposed tax is a renewal.

SECTION 3. That the tax for purposes specified in Section 1 and Section 2 hereof, shall commence in 2019 for the purpose of collection of said tax in 2020. First due in calendar year 2020, and shall be in effect for a period of five (5) years.

SECTION 4. That it is the desire of the Council that the ballot presented to the electors of the City of Campbell for the November 5, 2019 General Election, shall be substantially the following form:

SHALL THE 3.50 MILL RENEWAL LEVY ON PROPERTY, FOR THE PURPOSE OF PROVIDING FUNDS FOR THE CURRENT OPERATING EXPENSES OF THE GENERAL FUND OF THE CITY OF CAMPBELL COMMENCING IN 2020, FIRST DUE IN CALENDAR YEAR 2021, AND TO BE IN EFFECT FOR A PERIOD OF 5 YEARS BE PASSED?

FOR THE 3.50 MILL LEVY RENEWAL
AGAINST THE 3.50 MILL LEVY RENEWAL

SECTION 5. That the Clerk of Council be and is hereby directed to certify a copy of this Ordinance to the Board of Elections of Mahoning County Ohio, in order that the Board of Elections may make the necessary arrangements for the submission of such question to the electors of the City of Campbell at the November 5, 2019 General Election, as provided by law.

SECTION 6. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the citizens of the City of Campbell. The emergency being the time restriction for submission of this Ordinance to the Board of Elections. Therefore, this Ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor.
